- Dr. (Mrs.) Pradnya Palekar Shanbhag informed the members of the meeting that the students may keep the notes and books which has relevance to the syllabus of the examination paper nearby for copying. She also said that the students have ready access to various search engines for looking up the answers during the examination. She therefore asked for preventive and corrective measures.

- Dr. (Mrs.) Vandana Jain said that the students may write the answers to the important questions before the examination, thus adopting unfair means of answering. Hence, it was suggested that students should adjust the camera to reveal their surroundings so as to avoid the use of unfair means.
- Dr. Nutan Rao updated that many of the supervisors fail to send the invigilation report to the examination section. She also stated that the teachers are lacking in their invigilation duties to properly check for the student's signatures at the end of the answer sheet before submission. She also stated that Amey Sir has taken note of it and has promptly mailed to all invigilators regarding the same.
 - Dr. Amjad Ali stated that the students might receive assistance in answering the question paper from another person present nearby during the time of the online examination, thus the invigilator should take precautionary measures for preventing this unfair means. The invigilator thus has to follow the University guidelines strictly to prevent the unfair means.
 - Mr. Imtiyaz Ansari brought to the notice of the members that the invigilation duty hours should be increased from two hours to three hours to make up for the extra time required for conduction of online examinations, like generation of the Google Meet link, logging in fifteen minutes prior to the examination, solving student internet issues due to poor network, checking of submission of answer script to the respective subject teachers after the end of the examination, etc.
 - The meeting was concluded with the members all agreeing that the students should keep their cameras on at all times during the duration of the examination, and that proper steps would be implemented to look after the unfair means adopted by the students during the online examination, as per University guidelines.
 - This was followed by the vote of thanks from the coordinator, Dr. (Mrs.) Vanita Kanase, where she thanked all the members for their valuable time and active participation in the meeting.
