

MEMORANDUM OF UNDERSTANDING

Preamble

The objectives of the MOU are:

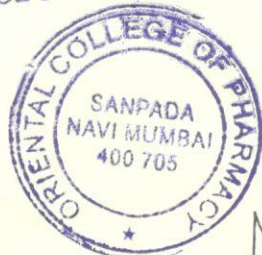
