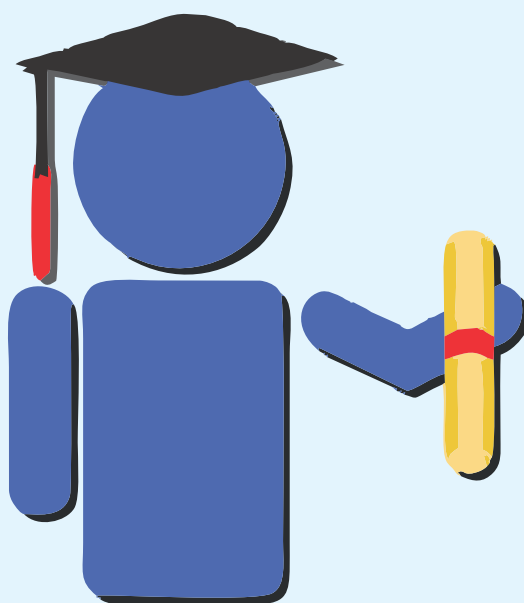

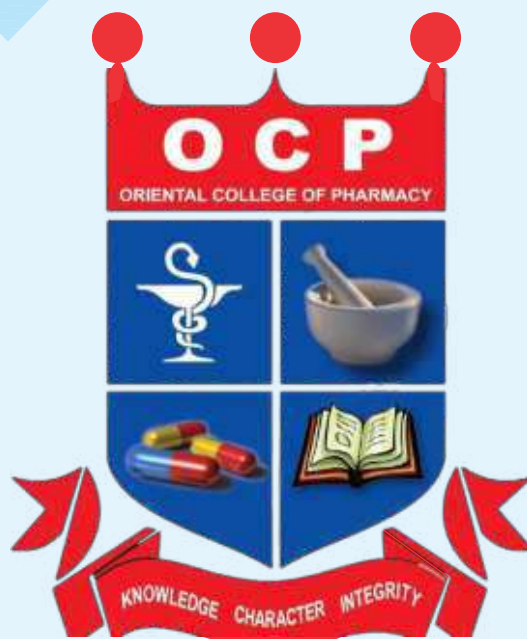

## General Rules & Regulations of OCP

## INTRODUCTION

- ❖ On the first day of college, the student has to attend Orientation Program with his/her parents so as to get detailed information of college and courses.
- ❖ The student is required to reach the college atleast half an hour before the lecture/practical sessions. He/she cannot leave the college before time as given in the regular time table. Identity card is compulsory and shall be carried to college everyday without which the student will not get entry into the college. If any student damages property of college then he/she will be penalized by disciplinary committee.
- ❖ Proper dress code should be followed by the students. It is to be noted that for girls dress above knee and singlets are not allowed.
- ❖ Importantly, each ward and parent has to sign the Undertaking framed by the college comprising of Rules and Regulations of the University and College.
- ❖ Minimum 85% attendance is compulsory and five marks are allotted for student's attendance per semester. This is the rule of University of Mumbai
- ❖ Students failing in two theory subjects and one practical examination are only allowed for admission in the next academic year.

- ❖ If a student remains absent in either periodic theory test or periodic practical test then he/she will be considered absent and no retest will be conducted in such a situation. The student has to write the class test and complete assignments from time to time. Journals are required to be completed and checked on the same day of the practical session.
- ❖ Students are not allowed to use mobile phones in the College Premises. In any circumstances, if he/she is found using mobile phone, then it will be seized by College Authorities and will be returned back after completion of the academic year.
- ❖ Student's should not indulge in any behavior or act that may come under the definition of ragging. He/she will not participate or propagate ragging in any form. He/she will not hurt anyone physically or psychologically or cause any other harm. If he/she is found guilty of any aspect of ragging / misbehaviour, he/she may be punished as per the provision of UGC Regulations or as per the law in force.
- ❖ While studying at the Institute, students will have to operate computers carefully and observe all safety regulations and see that no damage is caused to self, others or to the Institute property, machinery and equipment. In case it is found that they have caused any damage to the Institute property they shall be required to reimburse or make good the damage caused.
- ❖ Students must conserve electricity and water. They must switch off lights & fans when they leave the class room.

The college has an intake of 60 seats. Applications are invited against Hindi linguistic Minority, Institute level and CAP Vacancy quota for admission to First Year B.Pharm as per details below:

## ELIGIBILITY CRITERIA FOR MAHARASHTRA STATE CANDIDATE AND OUTSIDE MAHARASHTRA STATE CANDIDATE FOR ADMISSION TO FIRST YEAR OF DEGREE COURSE IN PHARMACY (AS PER DIRECTORATE OF TECHNICAL EDUCATION).

Candidate should have passed the HSC (Std.XII) examination of Maharashtra State Board of Secondary and Higher Secondary Education or its equivalent examination with subjects English, Physics, Chemistry and Biology / Mathematics AND secured minimum 50% marks i.e. not less than 150 marks out of 300 marks (minimum 45% marks i.e. not less than 135 marks out of 300 marks in case of candidates of Backward class categories and Person with Disability belonging only to Maharashtra State) in the subjects Physics, Chemistry and Biology / Mathematics added together (Maximum of marks obtained in Biology / Mathematics shall be considered for the purpose of addition)

**AND**

Obtained a non zero score at MHT - CET 2018

**OR**

Must have passed Diploma in Pharmacy or its equivalent examination with not less than 55% of marks in the aggregate of all subjects taken together at the Final Year Examination in single attempt and medium of Instruction as English from AICTE approved Polytechnics.

## Fees For B. Pharmacy

The fees prescribed by Fees Regulating Authority vide their notification on the website or as per Government of Maharashtra's directives and as approved by the concerned Authority. Full fees must be paid along with the necessary deposits as mentioned, at the time of admission. No student will be permitted ordinarily, to appear for any of the University/College Examinations if he/she has not paid the College/Exam fees for the year.

Once admission is granted by the college and if the student cancels the admission for any reason, he/she will be entitled for refund of the fees as per the following rules of DTE:

## M.Pharmacy Admission

### M. Pharmacy COURSE

**ORIENTAL COLLEGE OF PHARMACY** offers M. Pharm degree courses of two years duration as per University of Mumbai norms. The M. Pharm course is conducted for three specializations-

1. **Pharmaceutics**
2. **Quality Assurance**
3. **Pharmacology**

The syllabus is as prescribed by University of Mumbai.

### RULES OF ADMISSION TO FIRST YEAR OF TWO YEARS FULL TIME POSTGRADUATE COURSE IN PHARMACY INSTITUTES:

#### Qualification for Admission to M. Pharmacy

Candidates fulfilling eligibility requirements specified by the Mumbai University and Directorate of Technical Education will be considered for admission to M.Pharm.

For admission to M. Pharm. Course, the candidates have to qualify in the G PAT examination if they have to be considered for non-sponsored seats, which shall be offered to the candidates in the order of inter-se-merit. If such seats are filled, then GPAT qualified candidates shall be preferred for admission to the sponsored seats over Non-GPAT candidates.

#### For Admission to M. Pharmacy for GPAT Qualified Candidates

Candidate should be an Indian National and who possesses Bachelors degree or equivalent in Pharmacy from an AICTE approved institution, with at least 55 % marks (At least 50% marks in case of SC/ST category belonging to Maharashtra State only) AND should have a valid and qualified GPAT score.

### For Admission to M. Pharmacy

#### Non GPAT Qualified

Candidate should be an Indian National and who possesses Bachelors degree or equivalent in Pharmacy from an AICTE approved institution, with at least 55% marks at least (50% marks in case of SC/ST category belonging to Maharashtra State only) if the candidate has neither appeared for GPAT nor having valid and qualified GPAT score.

If candidates of Home University are not available, then the vacant seats shall be offered to candidates of Universities of Maharashtra in the order of inter-se-merit

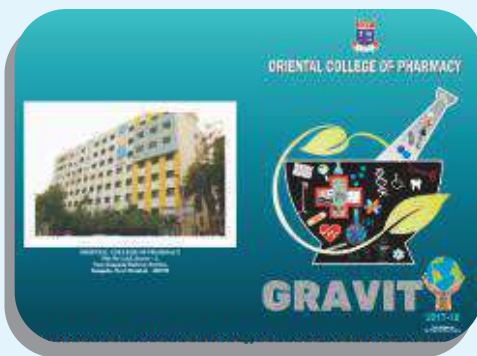




# College Building

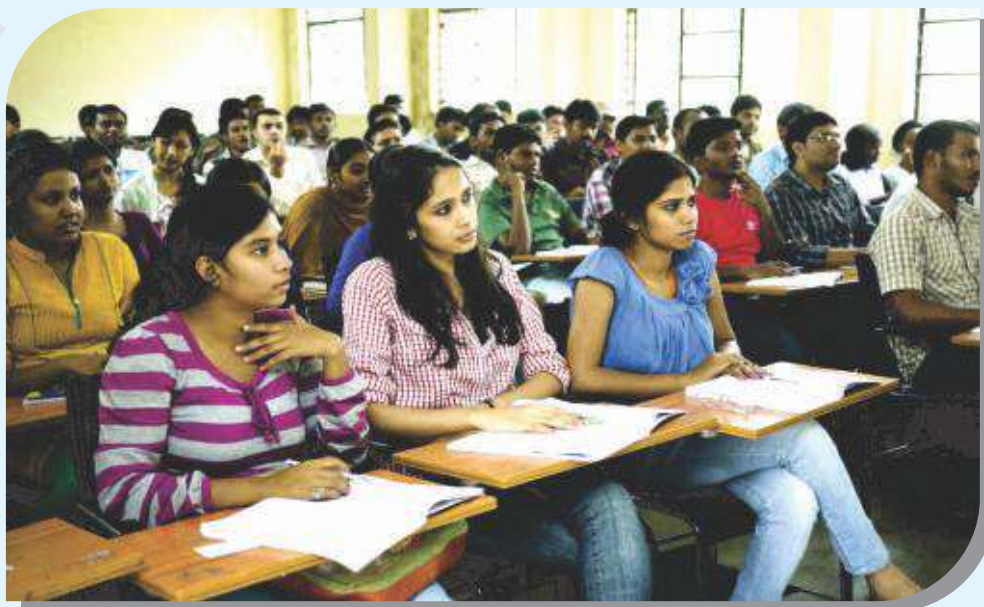




## GPAT Classes
