**Important Instructions :**

- 1) The candidates who have Auto freezed or chooses self freezed their allotment in CAP Round II shall report to the institute as per schedule.
- 2) The Institute shall verify the required documents (original documents as per the photo copies of the required documents verified by Scrutiny Center) and upload the admission of the candidates in the online system through Institute Login immediately within the schedule without fail and shall issue a system generated receipt of confirmation of admission & fee paid receipt to the candidate.
- 3) No institution, who has in its possession or custody, of any document in the form of certificates or any other documents deposited with it by a person for the purpose of seeking admission in such institution, shall refuse to return such certificates or other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in such institution. In such cases action shall be taken as per the directives given by the Government from time to time.
- 4) The institution shall not recover the fees for the subsequent years from the student seeking cancellation of his admission at any point of time before cutoff date of admission cancellation.
- 5) The SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC and EWS Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non Creamy Layer Certificate, EWS Certificate during registration, physical document verification and confirmation period should upload and verify original Caste/ Tribe Validity Certificate, Non Creamy Layer Certificate, EWS Certificate at Scrutiny Center and submit original certificate to the admitted institute on or before 03/09/2024 up to 05:00 PM otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate full fill eligibility criteria for open category.
- 6) SEBC Candidates who submitted receipt of Non Creamy Layer certificate during registration, e-verification or physical document verification and confirmation period should upload and verify original Non Creamy Layer Certificate at Physical Scrutiny Center or E-Scrutiny Center and submit original certificate to the admitted institute on or before 03/09/2024 up to 05:00 PM otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate full fill eligibility criteria for open category.
- 7) In case of SEBC Candidates, duration for submitting Caste Validity certificate will be as per the Maharashtra State Government Resolution No - संकेर्ण-2024/प्र.क्र.75/ आरक्षण -5 dated 22 July 2024.
- 8) For PWD Candidates, Disability nature must be permanent and a 40% benchmark is required, according to the rule. If you have submitted the wrong document and it has been verified by SC, your admission will be cancelled.
- 9) Candidates must submit their qualifying exam marksheet, clearly indicating that they meet the eligibility criteria, at the time of admission to the respective institute.
